
Monthly Market Review (August 2021)

NEWS HEADLINES

- Lending Rates: 15 banks charge above 20%; The Bank of Ghana has published a list of interest rates charged on loans by universal banks. Seeking to promote transparency in the pricing of loans, it showed ADB charging the highest rate of 24.89% whiles CAL Bank charged the lowest of 15.97%. (BoG)
- ESLA Plc undertakes debt swap; ESLA Plc has announced an exchange offer, swapping GH¢1.2bn of Tranche E1 bonds maturing in Oct. 2024 for Tranche E3 bonds due in Jun. 2029. ESLA Plc has thus, converted the maturity profile of the outstanding bonds from 2024 to 2029. (BFTOnline)
- Price gains in four equities drive GSE indices and market capitalization higher; The GSE-CI and the GSE-FSI were up by 9.42% and 15.09% respectively, while value of the market closed August at GH¢62.8bn (NorvanReports)

FIXED INCOME MARKET

- Yields on the treasury market picked up marginally in last week of August but still closed the month lower after losing grounds during the first three weeks.
- The GoG exceeded its targets for the auction of short-term securities within the month with the exception of the last week in August where auction 1761 saw a 26% undersubscription;
- A 2-Year GoG Bond issued during the month cleared at 17.25%;



KEY MACROECONOMIC INDICATORS


- Inflation for July 2021 rose to 9.0% from 7.8% in June, fueled by the hike in transport fares;
- The Monetary Policy Committee (MPC) however maintained the policy rate at 13.5%, determining that the risk to inflation and growth were broadly balanced.






TREASURY YIELD CURVE

- Unilever was the biggest price gainer whereas CPC recorded the largest price decline during the month.


